PUBLIC NOTICE

Pursuant to the requirements of the above, notice is hereby given that Westmeath County Council proposes to undertake the following works:

DEVELOPMENT OF A CO-WORKING HUB AND ENTERPRISE CENTRE AT THE SITE OF THE FORMER MASTER'S HOUSE, (A PROTECTED STRUCTURE REF: 027-008), MULLINGAR ROAD, KINNEGAD, CO. WESTMEATH, N91 FX09.

The proposed development will include the following:

- Relurbishment of the original Master's House Building (Protected Structure ref: 027-008 as per the Westmeath County Development Plan Record of Protected Structures: 2021 – 2027) including partial demolition works to facilitate a new rear extension.
- Construction of a new single storey extension to the rear of the Master's House (c.284m²) to be used as a reception, office space and meeting rooms.
- Site development works including improved pedestrian access and the upgrade of the existing ramp access with the provision of controlled vehicle access from the Mullingar Road.
- Hard and soft landscaping, including removal and replacement of the existing hedgerow along the western boundary.
- Provision of signage, lighting, bin storage, cycle stands and ancillary site works.

The Proposed scheme has undergone **Appropriate Assessment Screening** under the Habitats Directive (92/43/EEC) and screening for **Environmental Impact Assessment** under the EIA Directive 2014/52/EU.

Any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effect on the environment.

An **Architectural Heritage Impact Assessment Report** for the development works to the Master's House Building, a Protected structure, ref: 027-008 is available for inspection with this application.
